did wrongfully, unlawfully, wilfully and feloniously kill the
said Isaac McGhie by then and there strangling the said Isaac
McGhie with a rope, which said killing of him, the said Isaac
McGhie, by him, the said Walter McMillan, was then and there
without excuse, justification or authority of law, contrary to
the form of the State in such case made and provided, and against
the peace and dignity of the State of Minnesota.
